- Official transcripts (**MUST** show spring 2019 semester)
- Proof of full time enrollment for the **fall 2019 semester** (**from the school**, class schedule **does not** fulfill this requirement)

Students who are not enrolled full time and who have not maintained full time status at an accredited institution and not passed all courses will not be considered. Applications received after the July 12, 2019 deadline will not be reviewed.
